

Jiangsu Eastern Shenghong: 2024Q3 Results and Provision for Asset Implement

Suzhou City, China, October 30, 2024

Jiangsu Eastern Shenghong Co., Ltd. (the "Company") today reported financial results for the third quarter of 2024.

- During the reporting period (July 1, 2024, to September 30, 2024) (the "Reporting Period"), the Company achieved revenue of RMB 108,301,384,933.75, an increase of 4.46% over the same period last year, net profit attributable to shareholders of the listed company of RMB -1,419,062,479.87, a decrease of 155.96% over the same period last year. The changes in revenue and profit were mainly due to the insufficient macro demand and narrowing of product price differentials.
- The provision for impairment of assets for the first three quarters of 2024 decreased the total profit of the Company's consolidated financial statement for the first three quarters of 2024 by RMB 614.7091 million.
